SELLER OFFERS TWO YEAR GUARANTEE AGAINST ANY GENETIC OR CONGENITAL DEFECTS WHICH WOULD SIGNIFICANTLY LIMIT THE PUPPY'S LIFESPAN, SUCH AS A BAD HEART, KIDNEY, LIVER, OR LUNGS.

LIMITATIONS OF ANY AND ALL HEALTH GUARANTEES:

- BUYER MUST HAVE THIS DOG/PUPPY EXAMINED BY A LICENSED VETERINARIAN WITHIN 72 BUSINESS HOURS OF PURCHASE TO VALIDATE THIS HEALTH GUARANTEE AND TO VALIDATE THAT THE DOG/PUPPY IS IN GOOD HEALTH AND TO FOLLOW UP ON ALL NECESSARY IMMUNIZATIONS. IF SELLER IS SHIPPING DOG/PUPPY TO BUYER, 72 HOURS BEGINS UPON RECEIPT AT BUYER'S AIRPORT.
- ALL VET BILLS ARE THE SOLE RESPONSIBILITY OF THE BUYER.
- SHOULD ANY LIFE THREATENING GENETIC DISEASES OR DISABILITIES BE DISCOVERED DURING THIS EXAMINATION, THEY MUST BE ATTESTED TO IN WRITING AND SENT TO THE SELLER BY THE BUYER'S LICENSED VETERINARIAN.
- SELLER HAS THE RIGHT TO HAVE SELLER'S VETERINARIAN EXAMINE THE PUPPY. THIS (SELLER) EXAMINATION WILL BE AT SELLER'S EXPENSE.
 - TRANSPORTATION OF DOG/PUPPY FROM BUYER TO SELLER'S VETERINARIAN SHALL BE AT BUYER'S EXPENSE, UNLESS AN ALTERNATIVE AND MUTUALLY AGREED UPON AGREEMENT IS MADE BETWEEN BOTH PARTIES AND DOCUMENTED IN WRITING.

IF A GENETIC DEFECT IS FOUND BY YOUR VET WITHIN TWO YEARS, DOG/PUPPY WILL BE REPLACED AS SOON AS ONE OF EQUAL KIND AND VALUE IS AVAILABLE. NO MONEY WILL BE REFUNDED. SELLER IS NOT RESPONSIBLE FOR ANY OF THE BUYER'S VET BILLS. THIS HEALTH GUARANTEE IS FOR REPLACEMENT OF PUPPY ONLY. SELLER DOES NOT REFUND ANY MONEY FOR ANY REASON UNLESS IT CANNOT REPLACE THE PUPPY WITHIN 180 DAYS. SELLER DOES NOT GUARANTEE SIZE AT MATURITY, COLOR AT MATURITY, ADULT HAIR COAT, TEMPERAMENT, TRAINABILITY, ETC.
